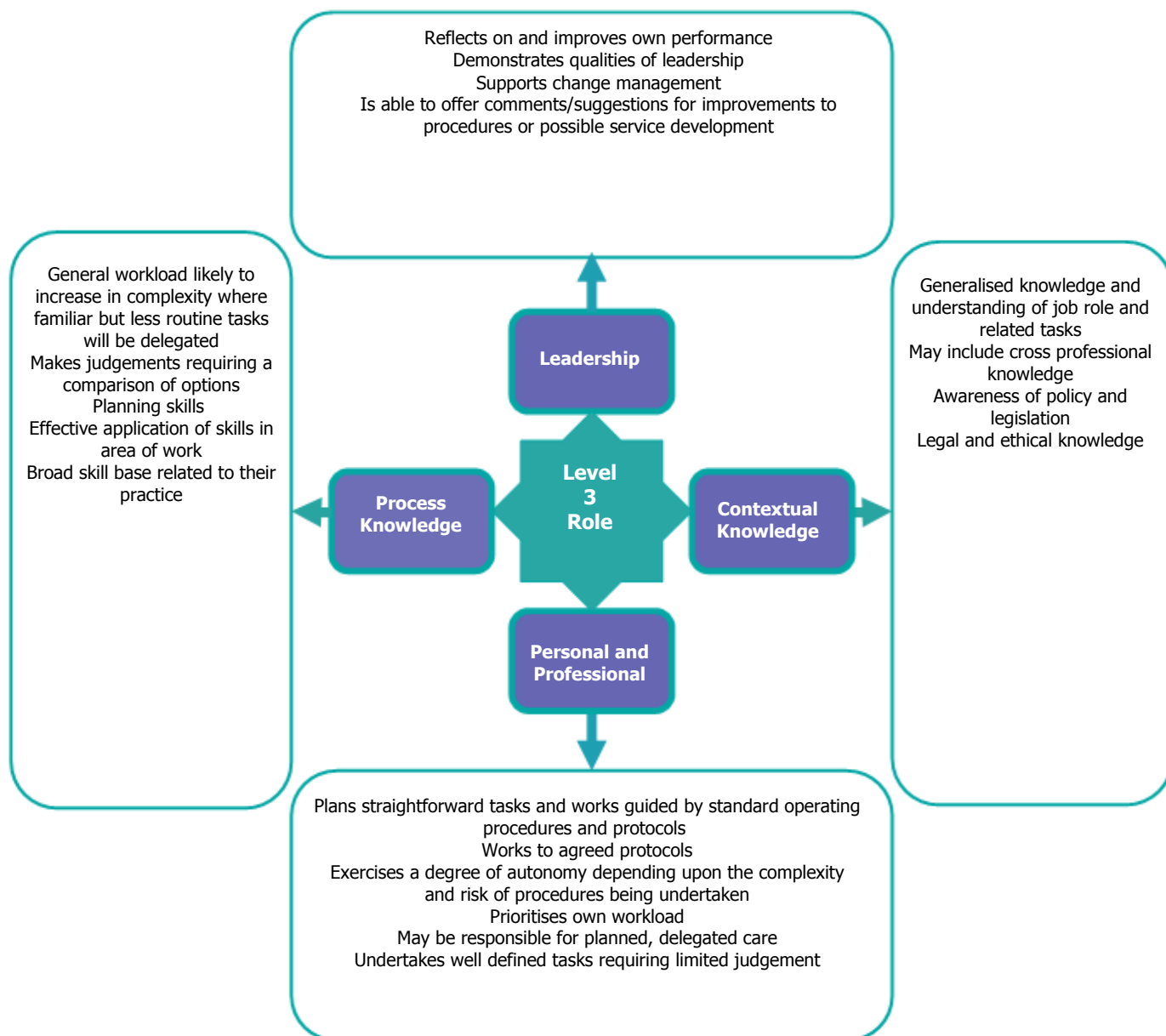

Key characteristics of a Level 3 Role



Definition of the Level 3 Role

People at level 3 require knowledge of facts, principles, processes and general concepts in a field of work. They may carry out a wider range of duties than the person working at level 2 and will have more responsibility with guidance and supervision available when needed. They will contribute to service development and are responsible for self-development.

Example of Role at Level 3

Senior Healthcare Assistant:

Senior healthcare assistants or technicians support the work of practitioners at all levels and may work as part of a team. They demonstrate an ability to carry out tasks, solving straightforward problems and making some judgements, with guidance and supervision available. They have skills in specific focussed aspects of service delivery.

These characteristics have been developed by Skills for Health working with employers and other stakeholders.

The post holder is a member of a team providing mental health services in the community

Scope of the Role

To be responsible for providing the link into the care co-ordination process for an allocated number of individual service users.

To assist in delivering a high standard of support and care to service users and their carers, promoting their equality, dignity and mental well being at all times.

To work with individuals to facilitate access and engagement in a range of community based activities, working across boundaries of care and organisations.

To work with service users to achieve their identified goals and access appropriate services provided on a regular and consistent basis.

Positively promote independent living of service users within the community
